Public Hearing: 2022 Shellfish Regulations: Discussion and Approval of 2022 Shellfish Regulations:

The Mashpee Select Board opened the Public Hearing on the 2022 Town of Mashpee Shellfish Regulations continued from February 28, 2022.

Ashley Fisher, Director of Natural Resources was in attendance with Shellfish Constable Donovan McElligatt to review the 2022 Shellfish Regulations with the Select Board. This matter was deferred from the February 28, 2022 meeting to ensure appropriate language relative to Aboriginal rights would be included in the document. It is anticipated the regulations would be promulgated effective April 1, 2022 for the upcoming shellfish season.

Town Manager Rodney C. Collins advised there has been discussions with Tribal leadership and with Town Counsel, however the regulations have not been fully finalized between the Town and Tribe. It was noted the Town and the Tribe are expected to conduct a joint meeting to further review and develop common consensus on this matter and other issues of common interest. It was anticipated the meeting would be held in March. Due to scheduling conflicts the collective meeting was delayed and it is expected to be held on May 16, 2022.

Peter Thomas, Chair of the Shellfish Commission made note of his disappointment this matter has been delayed with little input from the Commission. The Shellfish Commission represents the license holders of the Town of Mashpee and aspires to have the best shellfish program on Cape Cod.

The Town of Mashpee Shellfish Rules and Regulations have needed to be revised for some time. The Shellfish Commission has worked on the revisions for the past two years and ample communication has been provided months in advance. In the spirit of communication, a Tribal liaison attends regular meetings and it is the intention of the Shellfish Commission to give the Tribe what they have earned. Mr. Thomas recommended the dialogue remain transparent as the Town moves forward with this document.

In fairness it was noted the Tribal liaison to the Shellfish Commission is one individual. The Tribal entity maintains a Natural Resource Commission and a Natural Resource Department. Interaction and dialogue would provide the best practice with those entities. The Tribe is seeking to ensure its Aboriginal rights are respected, including more equitable efforts of the Town of Mashpee to value those rights, more so than land acknowledgement.

Town Manager Rodney C. Collins indicated the Town has the outmost respect of the Mashpee Shellfish Commission. A meeting with the Tribe is forthcoming, and this matter should be resolved soon. The Select Board agreed to continue the Public Hearing to May 16, 2022.

Carlton Hendricks, Vice-Chair of the Tribal Counsel reaffirmed the need to provide language into the draft Shellfish Rules & Regulations to acknowledge Aboriginal rights, and to maintain an open line of communication with the Town of Mashpee, directly through the Town Manager.

Consideration of Establishment of a New Open Space Committee: Planning Board:

Correspondence was received from the Planning Board dated March 2, 2022 requesting the Select Board consider the merits of establishing a new Open Space Committee, and seek a recommendation from the Town Manager regarding the committee's composition and its mission. The matter was taken under advisement, and would be placed on a future agenda for review.

Review and Approval of Comcast License Renewal:

The Select Board reviewed the Agreement between the Town of Mashpee and Comcast Cable Communications Management, LLC for the grant of the cable television license(s) pursuant to M.G.L. c.166A.

It was noted (2) Select Board members and the Town Manager were tasked to review this process. Significant changes to the prior contract are as follows;

The PEG annual capital payments will increase to \$65,000 for 10 years (\$650,000), an increase from the previous contract of \$44,758.30 for 10 years; \$447,583.

The PEG franchise fee has been increased from 4.5% to 5% of gross annual revenues.

Comcast will maintain a full-time customer service office in a town reasonably convenient to Mashpee with locations in Hyannis and Falmouth.

Presentations on Petition Articles: Solar Overlay District: NextGrid Daniel Serber:

Members of the Mashpee Select Board met with Daniel Server, Director of Land Development, NextGrid, Inc. to further review and discuss the proposed Solar Overlay District and the associated petition articles on the May 2, 2022 Annual Town Meeting warrant.

At the last meeting several questions arose. Mr. Serber provided additional information to clarify issues previously brought forth by members of the Select Board. The comments were outlined in a memorandum to the Select Board dated March 17, 2022.

It was noted that current annual tax payments for the properties NextGrid would be purchasing amount to \$11,176.20 or \$223,524. Next Grid is offering the Town of Mashpee \$1,872,000 over the 20-year life of the project. According to the tax analysis, the FY22 yearly total is \$13,174.35 with a 20-year total of \$346,372.01.

Mr. Serber indicated this offer is similar to an agreement negotiated with the Town of Bourne that has been fully vetted and approved by the Massachusetts Department of Energy Resources and Attorney General's Office. To create leverage the project would require partnership with the Town of Mashpee.

Discussion followed with respect to the zoning changes proposed via petition at the May Town Meeting. Terms of the Agreement would be negotiated at subsequent meetings. Mr. Serber indicated there would be 20 years of opportunity for the Town to change the underlying zoning to meet its future vision and needs. There are no after contract obligations aside from the decommissioning plan and bond which are required under the bylaw.

After 20 years NextGrid would have the option to re-buy the land from the Town. At minimum market value, the Town could sell the land for \$2 million. Under the decommissioning plan, all panels would be removed and recycled. The Town would also retain the right to re-sell the property if NextGrid was dissolved. The ability to transfer is not allowed in this Agreement.

Electrical savings to the Town under the SMART program would result in approximately 49% in savings and would allow residents to opt into the benefit which is estimated at 15% of their bill. There are benefits available for low-income users even if the project does not move forward.

Mr. Serber indicated the proposed bylaw requires a 300' setback from wetlands which would include a substantial amount of the disturbed sandpit, the most appropriate portion for solar which contains no trees of value. Additional language would be required to negotiate to provide a 2:1 set-aside since this would be a loss of 0% of the system size, and thus 40% of the total value or \$2,201,400 less benefit to the Town.

It was noted that an environmental assessment of the property has not been commissioned. It was recommended the assessment be a condition of the Agreement if it was to move forward. If known contaminants are identified, further assessment would thus be required.

In evaluating further negotiations, it was recommended that additional offset of costs for the uses of the land be considered. Payment in lieu of taxes was not recommended. Penalties could also be imposed for clean-up and removal. Language to protect the Town and to avoid litigation is highly regarded. The applicant was requested to clearly define the revisionary period.

In closing Mr. Serber indicated the offer is very fair and beneficial to the Town.

Timothy Martin was in attendance to discuss Petition Article 28 proposed to establish a 10% Real Estate Cap for all seniors. Mr. Martin of Russell Road detailed two primary points in his presentation. As noted; There is no limit on the degree to which property taxes can be raised in a year, and there is significant evidence that human judgement is applied in creating revaluations. The reassessment process is not entirely objectively driven by laws and requirements and with the magnitude of tax increases it is important the Town demonstrates that human judgements are applied without bias and appropriate.

Mr. Martin indicated he recently received a list of residential properties with 2020 to 2021 valuation increases of 50% and over, excluding new construction/improvements. For all of Mashpee there were 69 properties that had a total valuation increase in excess of 50%, with 66 properties located on Monomoscoy Island.

It is expected that a similar tax hike would be imposed next year. Mr. Martin respectfully requested the Town seek remedy for those who will be most affected by any continuing increases.

Mr. Martin stated that although there was a reduction in the tax rate, the number of properties receiving an increase in actual taxes over 40% was reduced from 87 to 46. The 46 waterfront properties are not the wealthy property owners that may be assumed. The most effected are the small homeowners on the waterfront.
