INTRODUCTION

As the current beneficiaries of the area's ecological assets, we share the accompanying responsibility of protecting and maintaining lands set aside for the public's enjoyment and recreation, to protect our water resources and plant and wildlife habitat, and to preserve some of the Cape's unique natural beauty.

Without a strong stewardship program to monitor the lands controlled by the Towns and other participating entities, open space properties can be degraded or lost. It is important to ensure any applicable conservation restrictions, boundaries and land use are maintained over time. A byproduct of a good stewardship program is greater public support for conservation lands.

The Land Stewards Program is a cooperative effort undertaken to provide a positive presence on open space lands. It combines monitoring, reporting and minor maintenance activities into a team effort aimed at protection and preservation of these invaluable assets. Volunteers can be Land Stewards or they can be specialized volunteers, working on specific projects.

Land Steward's Role:

The primary responsibility of the land steward is caretaking, "to be a presence on the land". The steward should monitor the land regularly, assist to keep trails cleared, and support clean-up efforts when necessary. Activities accomplished under this role are reported to the Conservation Department (Concom), contact information below. This position requires a regular time commitment from the volunteer.

Land Steward's Activities:

- Walk parcels at least 4 times per year
- Note how property is being used
- Notice any erosion problems
- Note any safety hazards (bring to attention of Concom)
- Make note of any vandalism
- Note location of any identified invasive plants
- Pick up small size/volume litter
- Be sure to take all the proper precautions when walking through the woods (ticks, bees, poison ivy, etc)

Land Steward Parcel Evaluations – A Physical for the Land

The land steward's second responsibility is to submit monitoring reports on the property to the Dept of Conservation. These documents act as the land's "physical", recording the health of the land and any changes over time.

Parcel Evaluation Criterion

- Record positive, neutral or negative changes on evaluation form;
- Return this information back to Concom. Reports can be dropped off at the Conservation Dept. office in Town Hall, 416 Great Neck Rd North or can be emailed to the department (information below).

What to Look For and Record:

- Clues that suggest change, (e.g. new roads, worn tire paths, piles of brush or debris, downed trees, trash, changes in vegetation, cleared land)
- Ask questions about any changes from neighbors or walkers you meet
- Look for special features, invasive species, unusual plant life, evidence of wildlife, terrain change.
- Observe trail usage and conditions
- Observe signage.

Specialized Volunteers

Specialized volunteers help with events outside the duties of the Land Stewards. This position does not require regular participation; instead, volunteers can choose to participate in events organized by the Conservation Dept.

Possible Specialized Volunteer Activities:

- Invasive species removal
- Beautification projects
- Trail maintenance or creation
- Debris removal

*** Both Land Stewards and Specialized Volunteers Do Not:

- Perform maintenance using power tools
- Construct new trails without approval from the Concom
- Enter into confrontational situations with others harming the property and/or performing illegal activities
- Introduce new plantings without approval from Concom
- Introduce new signage without approval from Concom
- Go off the established trails

NOTE:

Please be consistent with parcel name and address you give to Mashpee Police/EPO & Mashpee Conservation Dept. If the name and address are consistent, the police can better track areas where illegal activities are concentrated. Accurate records can help to produce year end statistics on problem areas. This will help direct management priorities on town conservation land and open space parcels.

PROCEDURES FOR REPORTING ILLEGAL ACTIVITIES

Illegal Dumping/Vandalism

Any illegal dumping should be reported immediately to the Mashpee Police Dept, Environmental Police Dept and the Mashpee Conservation Dept. If a volunteer happens to see dumping in progress, try to make note of the vehicle plate #, description, contents and the date/time/location that the dumping occurred. Stewards are encouraged to remove trash if they have the means to do so. A voucher for the Mashpee Transfer Station can be provided to any land steward who is willing to dispose of illegally dumped trash items such as furniture, appliances and other large ticket items. An onsite verification of the trash to be disposed with the conservation agent is required prior to the issuance of a transfer station voucher.

ATVs

All Terrain Vehicles are prohibited on town land. Experience has shown that gates and boulders are not effective in keeping ATVs out of open space lands. The steward should document, as accurately as possible, locations of physical damage, if the incursions appear to be continuous and any other information that could lead to the identification of the operator(s). All reports should be delivered to Mashpee Concom.

** If a steward finds needles or syringes or other items that represent a safety risk, they should make a description of the location that can be used by others to identify the location and notify the Police Dept. as soon as possible**.

Liability:

All Land Steward activities are considered individual "Volunteerism" and no liability insurance exists for participants in the program. All individuals are expected to exercise reasonable care and take precautions to protect themselves from harmful events

Open space areas may be home to insects such as ticks, mosquitoes and similar pests as well as plants such as poison ivy and poison sumac. **If driving on open parcel roads, 4 wheel drive vehicles are recommended**
