Review of Annual Town Meeting Warrant, Motions and Possible Amendments to Motions with the Finance Committee, Town Counsel and the Town Moderator:

The Board of Selectmen met in joint convention with the Finance Committee, Town Counsel and the Deputy Town Moderator to review matters associated to the Annual Town Meeting warrant of Monday, October 18, 2021.

In attendance was:

Town Counsel Patrick J. Costello

Deputy Town Moderator Edward Larkin

Finance Committee members: Jeffrey Pettengill, Gregory McKelvey, Darlene Furbush, John Miller, Mike Richardson, Patrick Brady, and James Carrier.

Article 1: To change the name of the Board of Selectmen to Select Board.

To petition the General Court to adopt Special Legislation.

At their September 13, 2021 meeting Ed Larkin recommended the Board consider an addendum to Article 1 of the Annual Town Meeting for transparency and to conform to the Town Charter by allowing the citizens of the Town of Mashpee the opportunity to ratify the Special Act by a Ballot vote if it is so endorsed. Following the rules of the Town Charter as it relates to the review and approval of Town Meeting articles, the Board deferred the matter to Town Counsel.

Town Counsel Patrick J. Costello advised the article can be voted three ways; Under the Home Rule Amendment requiring a 2/3rd's vote with approval by ballot, By petitioning the General Court to adopt the Special Legislation that relates only to the Town of Mashpee whereby ratification is not required by a subsequent vote of Town Meeting. And, By a full Charter Commission review with a designation to amend the Charter for this purpose.

Discussion followed with respect to the intended use of the Town Charter and allowing the majority of the residents who do not often attend Town Meeting, the opportunity to participate in this decision.

Town Manager Rodney C. Collins authorized Town Counsel to prepare a motion with the addendum. If the article does not pass, it was agreed the original article would be brought before the voters. A vote from the Board of Selectmen was not required for this action.

Petition Articles 23 – 28: Solar related articles.

An in-depth discussion followed with regards to Petition Articles 23 through 28. There is dire concern to the proposal relative to the development of medium and large-scale solar energy systems in the defined residential and commercial zoning districts in addition to the clear cutting of acreage and removal of natural vegetation. Of importance is the lack of negotiations regarding this project. If the zoning is passed by a vote of Town Meeting, the Town may lose beneficial leverage.

Discussion followed with respect to the attributes of this project. This includes increased revenue and energy savings. The Town would also be in the forefront as a leader in enhancing the density of solar projects with little impact to traffic and schools.

The Town received four bids in response to the RFB issued for replacement of the ramp at the Ockway Bay Boat Ramp. Attached are the results. Funding for the project was approved through Community Preservation Act at the October Town Meeting. All bids were well within the budgeted amount.

I recommend that a contract be awarded to **Robert B. Our Marine Division LLC** in the amount of **\$233,320**. Our Marine was the lowest, qualified bidder.

Our Marine has successfully completed a number of similar projects in other Cape Cod/Southeast MA towns in recent years, including in Harwich (Town projects; at Round Cove and Wychmere Harbor), Dennis (State project; Sesuit Harbor), in Yarmouth (State project; Bass River), and in Wareham (Town project; Onset Pier). The contacts I spoke with were effusive in their praise of Our Marine and would highly recommend them.

Our Marine understands the time sensitivity for the project due to time of year restrictions and are prepared to undertake the project within the required schedule.

Description

Approval of the layout for Red Brook Road was voted by Article 16 of the May Annual Town Meeting. A vote accepting the layout plan by the Selectboard is required prior to recording of the plan at the Barnstable County Registry of Deeds.

Background

Red Brook Road has been used and maintained by the Town as a public way for decades (the Town of Falmouth accepted the road in 1877). It was recently discovered that the road layout had never been approved by Mashpee Town Meeting and recorded. It seems this same discovery occurred in 1993 when layout plans were prepared but there is no record of a Town Meeting vote or recording.

Upon consultation with Town Counsel, it was determined that a confirmatory acceptance of the layout would be appropriate. New layout plans had to be prepared as the 1993 plans were unrecordable. These new plans are the ones presented to the Board for signature.

Recommendation

I recommend that the Selectboard vote to accept the layout of Red Brook Road as shown on the plans entitled "Layout Plan of Red Brook Road" dated October 21, 2021, Sheets 1-6.

Pros and Cons

Without the official acceptance of the layout of Red Brook Road by the Town, through a vote by Town Meeting and the Selectboard, there is no documentation to support it is a Town road. Town funds have been used for many years to maintain and improve the road. The Town has also submitted grant applications for state funding based on the assumption Red Brook Road is a Town road.





Dear Ms. Sherman:

Thank you for our recent conversation regarding the future of the current three-party development agreement process with Mashpee Commons, The Town of Mashpee and the Cape Cod Commission. After multiple conversations with town officials and staff, we understand the Select Board may choose to withdraw from the agreement at Monday's meeting. We would support that decision and follow suit by also withdrawing. It is time for a new chapter.

When we embarked upon the first-ever regional three-party development agreement process, there was great hope that thoughtful negotiation would yield a positive agreement. We hoped an agreement would benefit the community by changing what is currently a predominately single use zone to allow for a mixture of uses. These changes would address the local housing crisis, would spark economic development in the Town, and provide a steady level of growth over a 25-year period that would contribute to the town's tax base thereby moderating the future growth of property taxes. Unfortunately, it has become clear that the development agreement process requires further definition and refinement before becoming an effective planning strategy.

From the onset, the complicated Commission application procedure became a source of confusion and consternation for those unfamiliar with the process, including some elected officials. The application required Mashpee Commons to establish maximum parameters (i.e., proposed numbers of residential units and commercial space) for impact analyses, which were not necessarily intended to be the final metrics. This information, however, became engrained in the minds of project opponents who used the projected numbers to spread misinformation on both social media and at town committee meetings. Their unwillingness to listen to the merits, and their attacks on those who supported the agreement, derailed an already complex process which strayed from the proposed goal of collaborating on a plan for the future of the geographical town center.

The dissolution of the development agreement will not change our goal of providing housing in Mashpee, as we plan to independently pursue development opportunities to deliver attainable housing stock for the community.

Thank you to all who participated in and supported the idea of the three-party agreement process. We look forward to the possibility of revisiting a collaborative effort with the Town of Mashpee at a future date.
