Acting as the Licensing Authority for the Town of Mashpee, the Board of Selectmen opened the Public Hearing continued from August 24, 2020 on the Banning of the Sale of Alcohol Nips (50 ml) and the Banning of the Sale of Alcohol Nips in Containers of up to 100 ml in size as a Condition of any New, Renewed and/or Transferred License based on the considerations of public health, welfare and safety. Carol A. Sherman, Clerk read the Public Hearing Notice into record in accordance with posting requirements.

It was disclosed that numerous emails both for and against were received in the response to this Public Hearing. The Board was also in receipt of a petition to stop the ban on small sized liquor bottles. Communication with respect to this regard is retained on file in the Office of the Town Manager/Board of Selectmen.

The Board opened the Hearing to solicit comment.

Dena M. Rymsha, Liberty Liquors indicated she has been a responsible business leader for the past 25 years in the Mashpee community. With today's economic climate and due to the pandemic this is the worst time to institute a ban. Ms. Rymsha noted that at the last meeting the Select Board decided to defer their decision for two months conditioning the proposal that a plan be developed for littering in the midst of a global pandemic.

Ms. Rymsha recommended not focusing on one issue, but working together as a team and as a community to get to the root of the problem. As an industry the liquor licensed establishments have contacted wholesalers and others to support the clean-up of the town. Ms. Rymsha stated the businesses are trying to work together while struggling to keep their heads above water during this time. Ms. Rymsha suggested the Board give businesses time and grant the residents a voice in this Democratic process. It was recommended the matter be deferred to the spring town meeting to let the voters decide the outcome.

Ryan Kelleher a salesman of a large beer and wine wholesaler stated the proposal to ban alcohol nips does not make sense during hard times and local business decline. Retailers are expected to have substantially reduced revenues that may require a decrease in staff hours with possible layoffs. Mr. Kelleher agreed that litter is a problem which needs to be solved in the Town of Mashpee. It was recommended that more recycling bins be placed in high traffic areas. Mr. Kelleher also conveyed the timeframe of two months to develop a reasonable proposal is not realistic especially when over 500 Mashpee residents have voiced objection to the proposal. Mr. Kelleher supported the recommendation of Ms. Rymsha to open this matter to the residents to let the people of Mashpee determine the outcome.

Pete Proveneher indicated he believes in self-reliance and the freedom of choice. His primary concern in the safety problem effecting the residents as alcoholic nips encourage drinking on the go which results in driving under the influence and throwing containers out the window after consumption. Mr. Proveneher recommended the Board eliminate what is causing the problem, alcohol nips. An additional area of concern is litter. As a citizen Mr. Proveneher noted that he regularly collects litter from the roadways. Alcohol nips are a main source of litter that is tossed out of vehicles with drivers possibly impaired. Many residents are trying to get outdoors during this time of the pandemic and he is concerned with the safety of others.

Bryan Anderson owner of Andy's Market stated that he believes a vote of cancelling the sale of alcohol nips should be a vote of the Town and not a group of individuals making the decision. Mr. Anderson recommended the Board consider the decision at town meeting. Mr. Anderson also indicated the banning of the sale of alcohol nips will drastically affect many small businesses. A ban in two or four months is considered sudden. Mr. Anderson informed the Board the industry has met, but it has been very difficult to get all parties together during the pandemic to work towards a solution as many business owners are working 65 hours per week.

Dena Rymsha spoke again on this matter stating that those who leave a liquor store are rarely driving under the influence. Ms. Rymsha asked why is liquor industry is the only type of business banning together to clean-up the town.

Robert Million, Director of the Massachusetts Package Stores Association (MPSA) indicated the entire industry is working to address this issue across the state. The real issue is littering, it is not just alcohol nip bottles. As a community of retailers we are trying to solve the issue of litter. Mr. Million respectfully requested the Select Board grant additional time to solve the litter problem by having clean-ups and working together to get this done.

In closing there was a brief comment in support of additional waste receptors. But when all is said and done, nip drinkers may continue to throw their emptied container out the window.

Being no further comment, the Board of Selectmen acted as follows;

It was noted that communication was received from the Mashpee Chamber of Commerce dated October 20, 2020 stating that no member of the business community has contacted the Chamber with regards to the bottle issue. The Chamber in their memorandum stated it is their decision to remain neutral at this time and for the Select Board to continue to advise on this matter.

As discussion continued there was disappointment as the liquor businesses have not communicated to the Town to seek ways to solve this problem, especially when time was allocated to gather 500 signatures for the petition. There was also concern as the industry has consistently made minimal effort to support the proposed bottle bill on the sale of alcohol nips.

On social media there were recommendations in support of a bottle bill on the sale of alcohol nips. It was revealed the Board of Selectmen does not have this authority on the local level. A bottle bill was proposed by Representative Randy Hunt previously, but it lacked support and failed on the State level.

After consulting a liquor store in Bar Harbor, ME where the bottle bill is instituted on alcohol nips, the bottle deposit does not stop the users from purchasing or throwing the bottles out the window. The issue remains a public safety matter and a public nuisance. However, since the bill was enacted there is no litter of alcohol nips.

It was agreed that Representative David Vieira would be consulted regarding this matter. Representative Vieira also represents the Town of Falmouth where the ban on the sale of alcohol nips was passed with little objection. This initiative may prove beneficial to both towns.

Selectman O'Hara indicated he recently discussed this matter with Representative Vieira who was noted to be receptive to bring forth this approach to the governing legislation. In fairness to the business owner it is not reasonable to target the retailer rather than the consumer who is ultimately responsible for littering. It was suggested the Board take incremental steps to advocate the bottle bill with a deposit of \$0.50 or \$1.00 per bottle, and to work together to schedule a general clean-up of the Town of Mashpee.

If the ban on the sale of alcohol nips was instituted, the restriction would become a condition of the license. The Board of Selectmen has the ability to schedule a Public Hearing to make amendments to the license where appropriate and if a solution has been developed.

Motion made by Selectman O'Hara to table the discussion on this matter to June 1, 2020. There was no second. The motion did not carry.

### Eversource Presentation on Projects in the Town of Mashpee:

The Board of Selectmen met with Ronit Goldstein and Terri Feuersang, representatives of Eversource to review the 2020 Underground Duct System Improvement project in the Town of Mashpee.

The Town is expected to receive updates in areas to support 4,000 customers. The sites include Mashpee along Route 130 to Sandwich, and in New Seabury, the Popponesset Peninsula, the Greensward Road and South area as well as Cross Road and Garden Street. Most of the work involves cable and conduit.

It was noted the projects have been presented in detail to the Assistant Town Manager and DPW Director. The project also involves easements with private landowners. Work will be fully vetted with the Director of the Department of Public Works.

A Public Hearing sponsored by the Board of Selectmen is scheduled to be held on November 16, 2020. With proper permitting it is anticipated the project would begin at the end of this year. There will be public outreach with a point of contact for specific needs. Signage will announce the work along the roadways. There will be no overnight displacement. In the private road areas some of which are not occupied to date, project needs with be reviewed with the developer who retains control of the private areas.

There is no health implications related to this project. The exact level of voltage will be verified and disclosed to the Town Administrator/Board of Selectmen.

There was concern with regards to areas of archeological sensitivity, and the potential to impact ancient burials and homelands. This matter would be further addressed and verified to conform to environmental and archeological sensitivity. In the public roadways, all work would be conducted in the actual road layout.

<u>Discussion and Approval of Snow Plow Contractor Rates: Department of Public Works Director Catherine Laurent:</u>

Catherine Laurent, Director of Public Works recommended the Board of Selectmen approve an increase to the FY2021 Snow Plow Contractor Rates to attract and maintain contractors. The rate increases for the 4WD vehicles was reflected in a memorandum to the Select Board dated October 28, 2020.

Ms. Laurent indicated the rate increases will remain competitive with comparable towns and with MassDOT. The last rate increase was FY19. Failure to hire a sufficient number of contractors would delay the Town's response during and after a snow storm event. Approximately 20 contractors are hired each season.

### **OLD BUSINESS**

Update, Discussion and Possible Action Relative to COVID-19:

Town Manager Rodney C. Collins updated the Select Board of matters relative to COVID-19 as follows;

There is one new positive case bringing forth a total of 109 cases with 6 persons in isolation.

Governor Charles D. Baker has issued new Executive Order regarding COVID19 measures effective November 6, 2020. This includes;

Mandatory Night-Time Closing Period for Certain Businesses and Activities;

Businesses, facilities or activities included in the categories listed must close their premises to the public each day not later than 9:30 p.m. and may not re-open their premises to the public before 5:00 a.m.,

Restriction on Service and Sale of Alcohol and Adult-Use Cannabis during the Mandatory Closing Period.

Included is the directive from the Department of Public Health the Stay at Home Advisory urges all persons in the Commonwealth to remain at home between the hours of 10:00 p.m. and 5:00 a.m. to slow the spread of the virus, preserve hospital capacity and to save lives.

Face coverings are required at all public places. The gatherings at private residences are limited to 10 indoors and limited to 25 persons outdoors.

At this time Town Manager Collins has recommended that Town Hall remain on its current status with limited access to the public.

### **NEW BUSINESS**

<u>Discussion of Dredging Project at Mashpee Neck Marina: Department of Natural Resources Director (or designee):</u>

The Board of Selectmen reviewed communication received from Department of Natural Resources Director Ashley Fisher dated November 2, 2020 regarding the dredging project at the Mashpee Neck Marina. While on patrol on the morning of October 16, 2020 the Shellfish Constable noticed a large amount of silt being released into the waters by the Mashpee Neck Landing by the dredging project at the marina.

The next day the Conservation Agent inspected the work and fines were issued to Schultz Marine for violations associated to the Order of Conditions for the dredging project. This includes the following; A \$300 fine for failure to notify the Conservation Department of the start of the dredging, and a \$300 fine for adversely impacting the wetland resources.

Samples were taken on October 19, 2020 for fecal coliform. After a 24 hour incubation period all samples failed the fecal coliform testing. Samples on October 26, 2020 after the incubation passed under the 14 colony threshold. It was determined the area could be open for the taking of shellfish on November 1, 2020.

Ms. Fisher was in training and unable to attend this meeting. She did however answer several questions provided by Selectman Andrew R. Gottlieb in his memorandum addressed to the Town Manager dated November 2, 2020.

This is a private dredge project, and the permittee is required to manage siltation control measures on site, but failed to do so and jeopardized the Town's entire shellfish aquaculture program and resource for commercial fishermen. The private contracting firm also failed to comply with the permit by continuing work after notification. The contractor fully deployed a boom to further contaminate the site and did not communicate with the Conservation Department of the start and at the end of the project.

There was appalling concern as the contractor being informed of the violation on Friday, did not stop work until Monday. Non-compliance in a sensitive area of which the Town is expending a great deal of funds to improve water quality is an act of irresponsibility and an abuse of rules and regulations.

Town Manager Rodney C. Collins indicated he has consulted with Town Counsel on this matter and through the advice of Town Counsel will further discuss this concern with an Environmental Special Counsel. The Town of Mashpee will pursue all damage possibilities.

It was fully agreed the Board of Selectmen would review the adequacy of the Rules of Enforcement and Fines thereof.

### Discussion and Approval of Payment to Cabot Risk Strategies, LLC from the Injured on Duty Fund:

The Board of Selectmen was requested to authorize payment to Cabot Risk Strategies, LLC in the amount of \$1,000 a deductible payment claim to derive from the Injured on Duty Fund.

Motion made by Selectman O'Hara to approve payment to Cabot Risk Strategies, LLC in the amount of \$1,000 as referenced.

Motion seconded by Selectman Gottlieb.

### Update from Town Manager regarding Pickleball Courts:

In an effort to mitigate the neighborhood complaint regarding the noise emanating from the Pickleball Courts on Ashumet Road, a soundproofing firm was contracted to take readings of the courts and the sound wall (barrier fence). The evaluation is proposed to test the effectiveness of the barrier, review weak areas, and propose solutions to increase its effectiveness.

Results have revealed the barrier does reduce the noise from the pickleball courts to the neighboring homes. However, there is a lot of noise bouncing off a shed and within tree line where the fence did not have a barrier. To mitigate the noise it was suggested that all gaps be blocked, and to make the barrier fence taller and add absorption to the courts.

As an option a roof could be installed to further mute the noise. A feasibility study would determine the most suitable covering for the pickleball courts for sound control. It was agreed the budget for the pickleball courts would be reviewed and considered to fund the \$30,000 study. It was suggested that a local firm be consulted to obtain a cost estimate. The Board of Selectmen agreed to review this matter at the next meeting. The CPC may be consulted for additional funding.

### **Discussion of Comcast Contract Negotiations:**

To better prepare for negotiations relative to the Comcast Cable Television renewal due to expire in August of 2021, the Town Manager presented the 2011 contract to the Selectmen for review. Advance review will give ample time to further discuss the terms and conditions of the contract and any questions that may arise.

<u>Discussion and Approval of Appointment of a Selectmen Representative to the Mashpee Commons</u> Development Agreement Negotiating Team:

Motion made by Selectman Sherman to nominate Selectman John J. Cotton as the Selectmen Representative to the Mashpee Commons Development Agreement Negotiating Team. Motion seconded by Selectman Gottlieb.

<u>Housing Assistance Program:</u> The Board recently obtained notice from the Mashpee Housing Authority regarding their inability to administer the Housing Assistance Program. A draft policy is under consideration for this service to be administered by the Human Service Director and Council on Aging Director.

<u>Dedication of the Mashpee Community Garden:</u> In honor of Michael Talbot, the dedication of the community garden is planned on November 10, 2020 at 11:00 a.m.



### **Classification Hearing**

To: The Honorable Members of the Board of Selectmen,

In order to facilitate your Public Hearing on November 16<sup>th</sup>, 2020 regarding Tax Rate Classification; please see the accompanying recommendations and information.

The first point to be addressed is whether the tax rate should be "shifted" between categories of properties. This would result in a greater share of the tax burden up to 150%, being placed on Commercial, Industrial and Personal Property *(residential & commercial)* taxpayers by increasing their tax rate while reducing the tax rate for residential properties. Approximately 7.7% of Mashpee's taxable valuation is commercial and industrial properties. These properties have been greatly affected this year by the lockdowns and other aspects of the pandemic.

The second point for consideration is whether there should be a residential exemption of up to 35% for Mashpee residents. This shifts the tax burden only among the residential properties onto the higher valued homes, rentals and all part-time residents. For proper implementation of budgeting, software, additional staffing and most importantly to assure a timely tax bill mailing, a lead time of one year should be given to the Tax Collector and Assessing before the adoption of this exemption.

The third point is whether there should be an Open Space discount. This option would have little effect as Open Space parcels are already greatly reduced in value.

The final point for consideration is whether the Town of Mashpee should adopt a Small Commercial Exemption of up to 10% shifting some taxes to other taxpayers. Currently there are 50 out of the 345 commercial properties solely occupied by the owner. Few businesses would benefit and additionally would add further pressure to the sector most impacted by COVID.

To promote continued fair and equitable taxation, the Board of Assessors voted at their November 12<sup>th</sup> meeting to recommend a single tax rate be adopted with no residential exemption and no small business exemption and no discount for Open Space. All four points may be voted on individually or as one motion. A sample motion is included below.

Sample MOTION: I move that the Town of Mashpee adopt a tax rate Factor of "1" for all classes of property with no discount for Open Space, no Residential Exemption and no Small Commercial Exemption.

- SPLIT TAX RATE
- OPEN SPACE DISCOUNT
- RESIDENTIAL EXEMPTION
- SMALL COMMERCIAL EXEMPTION

### **Classification of Property**

Assessors must classify all real property according to its use as of each January 1<sup>st</sup> into one of four classes: Residential, Open Space, Commercial or Industrial.

### **Tax Levy Allocation**

Municipalities decide annually within limits established by statute and the Department of Revenue (DOR) the percentage of the tax levy that will be paid by each class of real property owners and personal property owners. The decision is made after a public hearing.

### THE CLASSIFICATION HEARING

### **Annual Hearing**

Before the tax rate can be set, the selectmen must hold a public hearing each year to consider the tax rate options available to the municipality under property tax classification. The hearing is held after the assessors have determined final values and classified all properties and reported this information to the DOR. These values set the parameters for the options that the municipality may adopt.

### **Hearing Notice**

Notice of the hearing must comply with the Open Meeting Law and any local charter, by-law or ordinance provisions. In addition, taxpayers must be notified of the hearing by a comprehensive public information release in a newspaper of general circulation in the community.

### Role of the Selectmen

The selectmen conduct the classification hearing and vote on the available tax rate options. The vote may be taken at the hearing or a later meeting.

### TAX POLICY DECISIONS

### **Tax Policy Options**

Municipalities have several options in distributing the tax levy among taxpayers under property tax classification. Use of these options results in multiple tax rates for different property classes because they change the components used to calculate the rate, *i.e.*, the amount of the tax levy being paid by, or the assessed valuation of, the class. The total tax levy remains the same.

### Single or Split Tax Rate?

Municipalities must decide whether (1) to tax all classes of property at their full and fair cash valuation share of the tax levy, which results in a single tax rate, or (2) to reduce the share of the tax levy paid by residential and open space property owners and shift those taxes to commercial, industrial and personal property taxpayers or vice versa, which results in a split tax rate.

### **Classification Exemption Options**

Municipalities may also consider whether to allow (1) an open space discount, (2) a residential exemption, and (3) a small commercial exemption.

### **Levy Allocation**

The selectmen must decide the percentages of the tax levy that each class of real property and personal property will bear. To do so, a residential factor is adopted.

The residential factor governs the percentage of the tax levy to be paid by Class One, Residential and Class Two, Open Space properties. The difference is shifted to Class Three, Commercial and Class Four, Industrial and Personal properties (CIP).

The adopted factor cannot be less than the **Minimum Residential Factor** (**MRF**) calculated by the DOR. The MRF represents the maximum shift allowed in the tax levy for the year and establishes the parameters for local decision-making.

### Single Tax Rate

A residential factor of "1" results in the taxation of all property at the same rate. Each property class pays it's full and fair cash valuation share of the tax levy. Example: If the value of all residential properties makeup 80 percent of the total assessed taxable valuation, residential taxpayers will pay 80 percent of the tax levy.

### **Split Tax Rate**

A residential factor of less than '1' reduces the share of the tax levy paid by the Residential & Open Space classes and increases the share paid by the Commercial, Industrial & Personal Property classes. The result is two tax rates: one for Residential & Open Space properties and a second, higher rate for CIP properties. A factor greater than '1' may be adopted, which would have the opposite effect.

### **Basic Minimum Residential Factor Parameters:**

- 1. Commercial, Industrial & Personal Property taxpayers cannot pay more than 150% of their Full and Fair Cash Value (FFCV) share of the tax levy (single rate share).
- 2. Residential & Open Space taxpayers must pay at least 65% of their Full and Fair Cash Value share of the levy.

### **Residential Exemption**

The selectmen may grant a residential exemption to all Class One, Residential properties that are the principal residence of the taxpayer on January 1. The only validation for proof of residence provided by law is a copy of the resident's tax return.

### Amount

The exemption may not exceed 35 percent of the average assessed value of all Class One, Residential properties. To calculate the exemption, the assessors first determine the average assessed value of all residential parcels. The adopted percentage is applied to this amount. The assessors must then determine which properties qualify for the exemption. (This step can take upwards of six months and is critical to avoid violating  $Prop\ 2\ \frac{1}{2}$ .) The assessed valuation of each residential parcel that is the primary residence of the taxpayer is then reduced by the same amount.

### Impact on the Tax Rate

Adopting a residential exemption <u>increases</u> the residential tax rate. The amount of the tax levy paid by the class remains the same, but because of the exempted valuation, it is distributed over less assessed value. This higher rate creates a shift within the class that reduces the taxes paid by homeowners with moderately valued properties. The exempted taxes are paid for by the owners of rental properties, second homes and full time residents with higher valued homes.

### **Small Commercial Exemption**

The selectmen may grant a small commercial exemption to all Class Three, Commercial properties that are occupied by businesses with an average annual employment of no more than 10 people and an assessed valuation of less than \$1,000,000.

### Amount

The exemption may not exceed 10 percent of the assessed value of each eligible Class Three, Commercial property.

### **Eligible Businesses**

For a business to qualify, the Director of the Department of Workforce Development must certify that the business had an average annual employment of 10 or fewer people at all locations during the preceding calendar year. By July 1 of each year, the Director provides assessors with a list of businesses that met that employment criterion. If a sole proprietorship or partnership does not appear on the certified list, the assessors may separately determine whether it met the employment criterion for the preceding calendar year.

### Impact on the Tax Rate

Adopting a small commercial exemption increases either the commercial and industrial tax rates (if a split rate is adopted) or the overall tax rate if there is no split rate. The amount of the tax levy paid by those two classes remains the same, but because of the exempted valuation, it is distributed over less assessed value.

This higher rate creates a shift that reduces the taxes paid by owners of properties occupied by small businesses and shifts them to larger commercial and industrial taxpayers. This exemption tends to benefit property owners (landlords) and not the small business owners themselves who often don't own the real estate.

Re: Annual Report to the Town of Mashpee from Cape and Vineyard Electric Cooperative, Inc. (CVEC) for FY 2020

Since 2007, the Cape and Vineyard Electric Cooperative (CVEC) has developed and managed price-stabilizing solar and battery projects for Cape and Martha's Vineyard towns, schools and other government organizations. These projects have resulted in \$16.9 million in cumulative annual savings to all participating government organizations.

CVEC has led 5 Rounds of solar or photo-voltaic (PV) initiatives producing power, with one more Round under development. A "round" allows projects to be grouped into a single, central Request for Proposal (RFP) which CVEC manages to ensure economies of scale and a high level of proven expertise. Future Rounds include PV as well as battery storage, where appropriate, to achieve the organization's and CVEC's shared goal of energy resilience.

Currently, I am the Town's representative to CVEC and serve on CVEC's Board of Directors.







### Description

Discussion of the Special Event and Fire Permit Application of Robert Weekes for a Birthday Party and bonfire on the South Cape Beach.

### Background

The applicant is requesting to host a Birthday Party on South Cape Beach on Friday, November 27, 2020 from 4:00 p.m. to 9:00 p.m. (*Rain Date Saturday, November 28, 2020*). No alcohol will be served. Only light snacks (e.g. cheese and crackers) will be served. A Fire Permit was also requested for a bonfire.

### Recommendations

Health - Approved, The event must comply with the current COVID-19 requirements for gatherings.

Building - Approved, no additional comments.

**DPW -** Approved, All debris from the fire should be removed once it is extinguished. All trash should be picked up and removed from the property (DPW only has one trash barrel onsite this time of year). No bathroom facilities are provided at the property at this time of year. If a portable toilet is requested, the applicant should contact DPW to make arrangements (fee required).

Fire - Approved, please see the attached memo from Deputy Chief Phelan for the Fire Permit.

Police - Approved, no additional comments.

### **Limits on Gatherings**

Governor's COVID-19 Order #54 (issued November 2, 2020)
Reduced gathering size limit for gatherings at private residences: indoor
gatherings at private residences are limited to 10 people and outdoor
gatherings at private residences are limited to 25 people. The limit on
gatherings held in public spaces and at event venues remains the same.
Requires that all gatherings (regardless of size or location) must end and
disperse by 9:30 PM.

Also requires that organizers of gatherings report known positive COVID-19 cases to the local health department in that community and requires organizers to cooperate with contact tracing. The gatherings order authorizes continued enforcement by local health and police departments and specifies that fines for violating the gathering order will be \$500 for each person above the limit at a particular gathering.

# Forms of Government in Massachusetts

#### **OVERVIEW**

There are 351 cites and towns in Massachusetts. Of these, 50 are cities and 301 are towns. There are numerous variations of local government structure. Generally the term "city" refers to a small legislative body such as a Council or Board of Aldermen (which meets frequently) and either an elected or appointed chief executive called a Mayor or Manager. Towns generally have a large legislative body, either an Open Town Meeting or a Representative Town Meeting (which meets at least annually and sometimes a few times a year). Towns also usually have a small (three or five member) elected executive Board of Selectmen as well as an appointed administrator called a Manager or Administrator.

#### CITIES

Most of the cities in Massachusetts operate with a Mayor/Council form of government such as Boston, Lawrence, Springfield, Fall River, and Taunton. However, some fairly large cities have a Council/Manager form of government such as Worcester, Cambridge and Lowell. In the last 30 years or so, since the adoption of the Home Rule Amendment to the Massachusetts Constitution, a few medium to larger size towns have adopted a so-called city form of government, either with a Mayor/Council form or a Council/Manager form. In many of these instances the municipality still calls itself a town. For example Amesbury and Greenfield now have a Mayor/Council form of government, while Barnstable and Franklin have a Council/Manager government.

#### **TOWNS**

Most towns (263) operate with an Open Town Meeting where any voter is permitted to attend and vote on legislative matters: budgets, bylaws, zoning, etc. Fewer than 50 towns operate with a Representative Town Meeting where voters elect representatives to attend town meeting. These representative legislative bodies vary from slightly less than 100 to more than 300. Towns of less that 12,000 may not have a city form of government and towns of less than 6,000 must have an open town meeting. The executive authority in towns is performed by elected boards of selectmen together with an appointed chief administrative officer called a Town Manager or Town Administrator.

The following attachments describe the more common characteristics of the varied forms of local government found in Massachusetts. Also attached are representative tables of organization for four of these described forms. Through use of the Home Rule Amendment, cities and towns may structure their local government in almost any manner they chose to adopt.

## Mayor / Council

#### Features

Voters directly elect a m ayor and Council. The Council size varies from 7 to 15. The mayor is the chief executive who appoints key officials and all or some boards, and prepares budget, approves contracts, negotiates with unions and oversees administration. A mayor may be empowered to veto some Council actions. The elected Council is the legislative body, and adopts budgets, adopts laws (ordinances, zoning, etc.), approves indebtedness (bonding), and may be empowered to approve or veto some Mayor appointments. The council also may appoint some boards and committees. Mayor is also usually a voting member of school committee. A limited number of boards and/or commissions may be elected.

#### Pros

- •Chief executive elected directly
- •Small legislative body
- •Frequent meeting of legislative body

#### Cons

- •Potential for political appointments to administrative positions
- ·Smaller citizen participation in decision-making
- •Less potential for professional administration in technical areas

# Town Council / Town Manager

#### **Features**

Voters elect Council and the Council appoints a City or Town Manager. Manager is chief executive, appoints key officials, prepares budget, approves contracts, negotiates with unions and oversees administration. The elected Council is the legislative body and adopts budgets, adopts laws (ordinances, bylaws, zoning, etc.), approves indebtedness (bonding), and may be empowered to approve or veto some Manager appointments. A town 'manager' is voting member of school committee but only on union contracts; a town 'administrator' sometimes serves in this role. A limited number of boards and/or commissions may be elected.

#### Pros

- •Smaller legislative body
- •Frequent meeting of legislative body
- ·Ability to establish experience and qualifications for chief executive
- •Ability to remove appointed chief executive at any time by vote of elected council

#### Cons

•Smaller citizen participation in decision-making

# Open Town Meeting / Selectmen Town Manager or Administrator

#### Features

All voters are eligible to debate and vote on budgets, bylaws and all matters brought before town meetings, and approve indebtedness (bonding). Town Meeting acts as the legislative body of the town. The executive branch of government consists of the selectmen and manager. An elected board of selectmen (usually 3 or 5) appoint a manager, sets policy, appoints boards and committees and may be authorized to approve or veto some of manager's appointments and approve union contracts. The manager is the chief administrative officer (CAO), appoints department heads and other employees, prepares budgets, awards contracts, negotiates with unions, and oversees administration. A town 'manager' is voting member of school committee but only on union contracts; a town 'administrator' sometimes serves in this role. Fair number of boards and/or commissions may be elected.

#### **Pros**

- •Direct and broad citizen participation in government
- •Ability to establish qualification for appointed chief executive
- Appointed executive can be removed at any time by elected board

#### Cons

- •Cumbersome decision making by legislative body
- ·Legislative body less likely to be knowledgeable on issues
- •Shared executive authority between elected board and appointed manager can obscure responsibilities.

# Representative Town Meeting (RTM) Selectmen / Town Manager or Administrator

#### Features

A limited number of voters are elected, usually by district, to represent all voters in a representative town meeting (RTM). Size can vary widely (less than 100 to more than 300). RTM is the legislative body of town and it debates and approves budgets, bylaws, and all matters brought before town meeting. RTM also approves indebtedness (bonding). The executive branch of the government consists of the selectmen and the manager. An elected board of selectmen (usually 3 to 5) appoint a manager, set policy, appoint boards and committees and may be authorized to approve or veto some manager's appointments. The board also approves union contracts. The manager is the chief administrative officer (CAO), appoints department heads and employees, prepares budgets, awards contracts, negotiates with unions, and oversees administration. A town 'manager' is voting member of school committee but only on union contracts; a town 'administrator' sometimes serves in this role. Smaller number of boards and/or commissions may be elected.

#### Pros

- •Somewhat larger (than Council) representative legislative body participates directly in government
- •Legislative body more likely to be informed on issues that open town meeting.
- •Ability to establish qualifications for appointed chief executive
- •Ability to remove appointed executive at any time by elected board.

#### Cons

- •Difficulty in achieving broad community 'representation', achieving quorums, and keeping the 'status' of town meeting members up to date
- •The size of the legislative body can present challenges in trying to educate and provide information to this group prior to the decision making process

Communities with a city form of government are listed in all capital letters.

Letters in parentheses for certain cities indicate the use of one of the optional plans of city government ("model city charters") as authorized by Massachusetts General Laws chapter 43 (Plan A, B, C, D, E, or F). Cities that are not identified by a letter in the final column are governed by provisions or special charters granted by the Legislature.

Some municipalities have adopted a home rule charter under the provisions of the Home Rule amendment and chapter 43B. The first year in which the home rule charter was adopted is in parentheses.

Massachusetts law provides that no town with a population of less than 12,000 may adopt a city form of government and no town with a population of less than 6,000 may adopt a representative town meeting form of government.

Information in this chart is compiled from an MMA survey of each city and town in the state. The surveys were completed by the municipal clerk in each community. In towns that do not have a chief municipal official, the chair of the Board of Selectmen fulfills that role.

Framingham voted in 2017 to adopt a city form of government with a mayor and council, effective Jan. 1, 2018.

RE: Town of Mashpee Chapter 107: Nitrogen Control Bylaw

#### Cape Cod Landscape Association:

The waters of Mashpee have been heavily impacted by nutrient loading from septic systems, stormwater run-off and fertilizer use. These are all sources of the limiting nutrients nitrogen and phosphorus. As nitrogen is the cause of excess algal blooms in the saltwater estuaries such as Popponesset Bay and Waquoit Bay, phosphorous is the cause of excess algal blooms in freshwater systems such as Santuit Pond.

As of 2014, Mashpee has implemented a Nitrogen Control Bylaw as a way to reduce excess nitrogen and phosphorus from entering our waterways by regulating use on managed turf lawns. This bylaw enacts time of year restrictions and restrictions on areas within 100 feet of wetlands. Performance standards of the bylaw include:

- Time of Year Restriction
  - Fertilizer containing nitrogen cannot be applied between October 30<sup>th</sup> and April 14<sup>th</sup>
  - Fertilizer containing phosphorus (without nitrogen) cannot be applied between
     December 1<sup>st</sup> and March 1<sup>st</sup>
- Fertilizer containing nitrogen and phosphorus cannot be applied to any impervious surface, and must be immediately removed if spilled or accidentally deposited
- Fertilizer containing nitrogen or phosphorus cannot be applied within 24 hours of a heavy rain event (heavy rain meaning rainfall greater than 0.25" per hour during the next 24 hours or rainfall greater than 1" in total in the next 24 hours)
- Fertilizer Containing Phosphorus without nitrogen cannot be applied within 20 feet of any
  wetlands (including freshwater or coastal wetlands, marshes, wet meadows, bogs, swamps,
  vernal pools, lakes, ponds, rivers, streams, creeks and estuaries)
- Fertilizer Containing Nitrogen cannot be applied within 100 feet of any wetlands (including freshwater or coastal wetlands, marshes, wet meadows, bogs, swamps, vernal pools, lakes, ponds, rivers, streams, and creeks) or within 50 feet of any estuaries

The fine for the first offense shall be no greater than \$150. The fine for a second offense shall be \$250. The fine for a third and each subsequent offense shall be \$300. The enforcement authority includes the Agents of the Board of Health, the Conservation Commission, and the Department of Natural Resources.

If companies are unsure if there are wetlands present on the property, please ask the homeowner or check with the Mashpee Conservation Department at (508) 539-1424. #### **CHAPTER 107-NITROGEN CONTROL BYLAW**

History: Added 10-20-2014 ATM, Article 13, approved by Attorney General 2-23-2015. History: Amended 5-1-2017 ATM, Article 34, approved by Attorney General 10-31-2017.

#### §107-1 Purpose:

A town bylaw to conserve valuable waterways and other resources that increase our property values, that protect our unique environment vital to our economy, and that reduce the financial burden on taxpayers and property owners by regulating the outdoor application of nitrogen and phosphorous on turf. The regulation of fertilizer applications will reduce the overall amount of excess nitrogen and phosphorous entering the town's resource areas as defined in the Mashpee Wetlands Protection Bylaw (§174-2) and regulations. Reducing excess phosphorous helps protect the water quality of Mashpee's ponds and streams. Reducing excess nitrogen helps protect and improve water quality of Mashpee's two (2) valuable estuaries-Waquoit Bay and Popponesset Bay-and their associated bays, coves and waterways; as well as Mashpee's many ponds and streams.

This town bylaw is also critical to reducing Mashpee's Total Maximum Daily Load (TMDL) of nitrogen. Mashpee waters do not meet the Clean Water Act standards because of excess nitrogen entering the town's estuaries. The Cape Cod Commission has estimated that reducing nitrogen from outdoor lawn applications to coastal estuaries and embayments by fifty (50) percent could save the taxpayers of Mashpee forty (\$40,000,000) million dollars in sewering and other wastewater treatment expenses. Scientifically we know can be done without affective the quality of turf in Mashpee.

#### §107-2 Applicability:

This bylaw shall apply to and regulate any and all applications of nitrogen and/or phosphorous (phosphate) fertilizer on managed turf areas within the Town of Mashpee. §107-3

#### §107-3 Definitions:

"Agriculture" includes farming in all its branches, generally as the cultivation and tillage of the soil, dairying, the production, cultivation, growing and harvesting of any agricultural, floricultural, viticultural or horticultural commodities, and shellfishing, including preparations and delivery to storage or to market or to carriers for transportation to market.

"Best Management Practices" (BMP", means a sequence of activities designed to limit a nonpoint pollution source. For the purposes of the bylaw, BMP, means the most current edition 78 of "Best Management Practices for Soil and Nutrient Management in Turf Systems", prepared by University of Massachusetts Extension, Center for Agriculture, Turf Program.

"Certified Fertilizer Applicator" means a person certified by the Cape Cod Commission, Cape Cod Cooperative Extension, or Town of Mashpee departments, or any combination thereof, to apply fertilizer and manage turf in conformance with BMP.

"Compost" or "Organic Compost" means the biologically stable, humus-like material derived from composting or the aerobic, thermophilic decomposition of organic matter.

"Fertilizer" means a substance that enriches the soil with elements essential for plant growth, such as nitrogen, phosphorus, potassium or other substances; fertilizer does not include those nutrients that are normally excluded from fertilizer such as chemicals that are part of horticultural gypsum, dolomite, limestone, lime, Jersey greensand, grass clippings, or compost topdressing; compost tea and liquid seaweed, as defined and applied in accordance with standards in Section 5(f), is also excluded from the definition of fertilizer.

"Heavy Rain" is a rainfall greater than 0.25 inches per hour during the next twenty four (24) hour period or a rainfall of greater than one (1") inch total in the next twenty four (24) hour period.

"Impervious Surface" means any structure, surface, or improvement that reduces or prevents absorption of storm water into land, and includes concrete, asphalt, paver blocks, gravel, decks, patios, elevated structures, and other similar structures, surfaces, or improvements.

"Lawn Patch Product" is premixed blend of grass seed, fertilizer, and mulch.

"MDAR Fertilizer Regulations" means the most recent regulations of Mass General Law 330 CMR 31.00: "Plant Nutrient Application Requirements for Agricultural Land and Land Not Used for Agricultural Purposes", developed by the Massachusetts Department of Agricultural Resources (MDAR) pursuant to its authority under MGL c.128, Sections 2(k) and Section 65(A), as amended by St. 2012, c. 262. 330 CMR 31.00

"Natural Organic Fertilizer" is a fertilizer product that is derived from either a plant or animal product containing one (1) or more elements, other than carbon, hydrogen and oxygen, which are essential for plant growth. These materials may be subject to biological degradation processes under normal conditions of aging, rainfall, sun-curing, air drying, composting, rotting, enzymatic or anaerobic or aerobic bacterial action or any combination of those conditions. These materials are not mixed with synthetic materials or changed in any physical or chemical manner from the material's initial state except by manipulations such as drying, cooking, chopping, grinding, shredding, hydrolysis or pelleting.

"Naturally Vegetated Buffer Zone" means areas of indigenous vegetation. Plantings may be considered as naturally vegetated if they meet the standards of the Mashpee Conservation Commission and include a low-growing herbaceous layer of vegetation, which includes grassland, heathland or meadow plantings.

"Nitrogen" (N) means an element essential to plant growth. For the purposes of the bylaw, nitrogen may be available as slow-release, controlled-release, timed-release, slowly available, or water insoluble nitrogen, which means nitrogen in a form that delays its availability for plant uptake and use after application and is not readily available to turf and other plants; and/or quick-release, water soluble nitrogen which means nitrogen in a form that does not delay it availability for turf and other plant uptake and is rapidly available for turf and other plant uptake and use after application. 79

"Natural-Based Fertilizer" is a fertilizer product that is derived primarily from either a plant or animal product containing one (1) or more elements, other than carbon, hydrogen and oxygen, which are essential for plant growth. These materials may be mixed with lesser amounts of synthetic materials. For the purposed of this bylaw, Natural-Based Fertilizers are exempt from the restrictions on the application of phosphorous containing fertilizers, if and only if, the phosphate or phosphorous is derived from a natural-organic source.

"Person" is any individual, partnership, corporation, firm, association, authority, trust or group, including, but not limited to, a municipality, county, the Commonwealth and its agencies, and the federal government.

"Phosphorus" (P) is one (1) of three (3) primary nutrients needed by turfgrasses. Although it is present in small amounts in turfgrass tissues (0.3-0.55 percent on a dry weight basis), phosphorous is extremely important for rooting, seedling development, cell division, and the synthesis of various compounds used by plants. Phosphorus (phosphates) can be supplied to turf as inorganic (synthetic) and/or natural organic fertilizers. Inorganic phosphorus fertilizers include superphosphates and ammonium phosphates. Natural organic fertilizers typically contain phosphorus derived from plant or animal byproducts.

"Phosphorus Containing Fertilizer" is turf fertilizer labeled for use on lawn or non-agricultural turf in which the available phosphate content is greater than 0.67% by weight, excluding Organic Compost, Natural Organic Fertilizer or Natural-Based Fertilizers where the phosphate is derived from natural-organic sources.

"Saturated Ground" means soil soaked with moisture so that it cannot absorb any more liquid.

"Soil Test" is a technical analysis of soil conducted by a laboratory using methods and procedures recommended by the University of Massachusetts Amherst Extension Program as appropriate for Commonwealth soils.

"Turf, Lawn, or Sod" means any non-crop land area that is covered by any grass species, excluding meadows, grasslands, flower or vegetable gardens, pasture, hay land, trees, shrubs, turf grown on turf farms or any form of agricultural production or use.

#### §107-4 Performance Standards

All application of nitrogen and/or phosphorus to turf shall comply with the following standards:

A. The application of nitrogen is prohibited between October 30th and April 14th unless specifically permitted by the Town Board of Health, the Town Conservation Commission or the Board of Selectmen, as set out below. The application of phosphorous or Phosphorus Containing Fertilizer, with or without nitrogen, is prohibited in all circumstances between December 1st and March 1st. Based on early spring or fall weather conditions, soil temperature and degree of turf emergence from dormancy, or other relevant condition, and using the guidelines of the BMP, the Town Board of Health, the Town Conservation Commission, or the Board of Selectmen may permit earlier or later application of nitrogen, in which case such extended period shall be announced by notice or publication. A working group may be established by the Board of Selectmen or the Conservation Commission to assist in undertaking the duties referenced in this paragraph.

B. No person shall cause nitrogen and/or phosphorus from any fertilizer application to apply to, or otherwise be deposited on any impervious surface including parking lot, driveway, roadway, sidewalk, frozen soil or ice. Any fertilizer applied, spilled, and/or deposited 80 on any impervious surface, either intentionally or accidentally, must be immediately and completely removed and contained and either legally applied to turf or any other legal site or returned to an appropriate container.

- C. No person shall apply nitrogen and/or phosphorus twenty four (24) hours before or during a heavy rain event or apply nitrogen and/or phosphorus onto saturated ground. An application of nitrogen and/or phosphorus should be watered in with nor more than one quarter (0.25") inch or irrigation or natural rain within the next twenty four (24) hour period.
- D. The application of phosphorus containing fertilizer without nitrogen is prohibited within twenty (20') feet and the application of nitrogen is prohibited within one hundred (100') feet of the following resource areas, as defined in The Mashpee Wetlands Protection Bylaw, Section 2 and regulations; any freshwater or coastal wetlands; marshes; wet meadows; bogs; swamps; vernal pools; lakes; ponds; rivers, streams; creeks; and estuaries, an application of nitrogen is prohibited within fifty (50') feet of that protected resource area. An application of nitrogen is prohibited within one hundred (100') feet of any rivers; streams; and creeks, as defined in the Rivers Protection Act, Chapter 258 of the Acts of 1996. There are alternative methods of enhancing turf within application of nitrogen; see Sections 5(e) and 5(f). A Certified Fertilizer Applicator may apply to the Town Conservation Commission for approval to authorize limited applications of nitrogen on turf within these prohibited areas. A working group may be established by the Town Conservation Commission to assist in undertaking the duties referenced in this paragraph.
- E. No person may purchase and apply, or authorize any person, by way of service contract or other arrangement, to apply any phosphorus containing fertilizer on lawn or nonagricultural turf, except when:
  - 1) a soil test taken not more than three (3) years before the application indicates that additional phosphorus is needed for growth of that lawn or non-agricultural turf; or
  - 2) the phosphorus containing fertilizer is used to establish new lawn or nonagricultural turf on bare ground or as part of renovation of a lawn or nonagricultural turf area. The use of phosphorus for the purposes of establishing a new lawn or non-agricultural turf area, or for renovating an existing lawn or nonagricultural turf is limited to the first (1st) growing season.
  - 3) If the soil test indicates that additional phosphorus is needed for growth of a lawn or non-agricultural turf, application of additional phosphorus shall not exceed the UMass Guidelines.
  - 4) Any person who applies phosphorus containing fertilizer, except those making non-professional applications, shall maintain records for three (3) years of each application made. The following information shall be recorded, when applicable: (a) Name of applicator; (b) Date of application; (c) Address or location description of the application site; (d) Soil test results for management units; (e) Type and amount of phosphorus containing fertilizer applied

#### §107-7 Enforcement Authority

The enforcement authority for all performance standards shall be the Agents of the Board of Health, the Conservation Commission, the Department of Natural Resources or their designees. The fine for the first (1st) offense shall be no greater than one hundred fifty (\$150) dollars. A warning in lieu of a fine or other enforcement action for the first (1st) offense can be issued at the discretion of the enforcement authority. The fine for a second (2nd) offense shall be two hundred fifty (\$250) dollars. The fine for each subsequent offense shall be three hundred (\$300) dollars.

#### §107-8 Severability Clause

Should any section, part or provision of this bylaw be deemed invalid or unconstitutional, such decision shall not affect the validity of the remaining terms of this bylaw as a whole or any part thereof, other than the section, part or provision held invalid or unconstitutional.

Cotton Chair, Mashpee Board of Selectmen When COVID-19 hit our shores, the Cape Cod region (southern Plymouth County including Plymouth and Wareham, all of the towns on Cape Cod, and the islands of Martha's Vineyard and Nantucket) were enjoying full employment and actively engaged in propelling our blue economy vision forward. Since the March 11<sup>th</sup> state of emergency declaration, nothing has stopped this work. In fact, the blue economy vision has resonated and spread beyond Nantucket, Dukes, Barnstable and Plymouth Counties into Bristol County and a closer partnership with UMass-Dartmouth. With REDO funding support, we will continue collaboration to execute our implementation plan <a href="https://www.bluecapecod.org/implementation-plan-report/">https://www.bluecapecod.org/implementation-plan-report/</a>.

The Blue Economy Initiative plan commissioned through support of the Massachusetts Seaport Economic Council, proposes actions that have begun to foster growth in the region's water-based economy. Prepandemic, the Commonwealth derived 2.6% of direct employment and 1.3% of direct gross state product from the maritime economy. In fact, the "dark blue" economy, that which is directly dependent on water, in the Cape region was worth 6% of the region's revenues and employed 4% of the workforce. More broadly, the overall blue economy continues to be a significant economic driver for the region, representing 12% of jobs and 11% of gross revenues.

Since the onset of COVID-19 business impacts, the blue economy plan is being adjusted to reprioritize concepts such as the Blue Wheelhouse accelerator for water-based technology business support services. We are actively fund-seeking for this concept, since there was predicted growth in dark blue industries through 2022: of 2.6% in the region, and of 4.3% in Cape & Islands. Further, the MassHire Workforce Development Board for the Cape & Islands is updating its Blueprint with increasing focus on the blue economy based on the statistics on the growth of the Cape Cod region's Blue Economy from 2003 to 2014, where blue establishments increased 42% (from 2,180 to 3,104), employees in blue business increased 50% (from14,412 to 29,093) and annual payroll for blue businesses increased by 111% (from \$574M to \$1.21B).

Since the pandemic, the volume of all categories of businesses seeking assistance has mushroomed, while our organizational capacity has shrunk. Further, there are no grants for organizations with no payroll (i.e. CCEDC, Inc.) or for 501 c 6 organizations (i.e. the chambers of commerce in this partnership.) However, we have nevertheless ramped up our frequency of meetings, webinars, 1:1 counseling, lobbying for business assistance programs, and more. For the balance of FY 21, we propose to continue assisting the massive numbers of business that have reached out to our collective organizations for business survival planning, loans and grants, and to propel the next economic wave in a post-COVID-19 environment with a complete review of the region's current state and future potential, while we advance housing, skills training, climate adaptation and a global reputation for the blue economy. Our work plan follows:
