

Beach Sampling Program

The Barnstable County Beach Sampling Program has been testing fresh water for E.coli weekly during the swim season for 17 years now. In Mashpee Wakeby, both Attaquin and Camp Farley sites are tested. lf E.coli is present, it may indicate the presence of a condition that has potential to cause illness, usually a mild gastroenteritis. This year, four bathing beach sample analysists have collected and analyzed the samples in Mashpee Wakeby. The Camp Farley site Tested negative from June 6th through August 29^{th,}. Attaquin Beach site tested negative except for August 29th and passed the retest on August 30^{th.} Storm water runoff is the dominant cause of elevated indicator levels. Animal waste from pets may contribute, as well as other wild animals.



Lake Levels



On October 1 st., after a dry summer, the lake reached its lowest level at 55.3' above sea level. It had increased to 55.8' and 55.9' in April and May, when we had a very wet spring. Levels for the summer held at 55.6-55.7, higher than usual. Levels above 55.5' cause erosion and damage to the shoreline.

Minor adjustments of boards which help control water level for the herring migration are managed by Drew McManus in Conservation and the Mass Department in Marine Fisheries.

The committee, which checks the lake level every two weeks, has asked the Town to replace one of the gauges which is becoming worn.

This picture of the gauge in the cage by the outflow of the Mashpee River is where the lake level is measured.

Lowell Holly Reservation

Winslow Dresser, stewardship manager for the South Coast, which includes Lowell Holly Reservation, reported a quiet summer. Ranger staff maintained operations at the beach and seasonal parking area with few issues Again , the beach area was open only to non motorized boats. Water testing continued with Barnstable County, producing good results for the season and only a solitary exceedance (not repeated in subsequent testing).

Typical stewardship work was completed on the property, including blowdown clearing on the trails, installation of more water bars for erosion control and brush clearing at the So Sandwich Rd. parking area. As always, they invite everyone's support through membership with the Trustees of Reservations. Plans for the winter include repairing wash-outs on the seasonal drive, regrading the parking area and updating the trail maps.

Mashpee Harbormaster

Committee members were pleased to meet Mashpee's new Harbormaster at our July 23rd meeting. Jeffrey Smith has over 20 years' experience with the Coast Guard. He is married with two children.

Jeff attended our August 27 meeting and gave us a summary of his first summer on the job particularly on Mashpee and Wakeby lakes. He was working with nine assistants this year and the added coverage on the lake lead to a much quieter boating season. There were over 224 hours logged on the lake and verbal warnings and citations were issued. Several PWC owners were sent off the lake after the 7 PM deadline. Most boaters followed the rules of navigation with the additional harbormaster coverage.

Jeff also enforced the 15 minute stay on the beach by the boat ramp. It is to be used strictly for launching or removing boats from the lake. He will begin tagging moorings soon.

Moorings

Mooring permits are issued for a period of one year And expire on December31st.

All mooring permits must be renewed by April 30th.

Winter sticks must be painted white, numbered and float upright at all times at not less than a 45 degree and have a minimum exposed length of 18" above any tide level.. Winter spar buoys may be used only from October1st to May 31st.
