I assure you that I am not attempting to be flippant either and I want to be transparent. The concept of the cell tower originated with the former Assistant Town Manager, Tom Mayo. It was considered a priority due to public safety factor. The Board of Selectmen assigned it to me as a professional goal. The location site was recommended by former Town Planner Tom Fudala. In full disclosure, he was under the impression that the Town was going to build it instead of issuing RFPs. The site as I recall was always Station #2 because it had to be in the south end and it was the last parcel of Town property in the area suitable for such purpose. The focus for the Town was to erect a tower to establish a repeater system so that police and fire could communicate on portable radio. There were many "dead spots" in the south end over the years. What changed is that instead of the Town constructing the tower, it opted for the RFPs so we saved money. Instead of spending money, we were in a position to receive revenue. I expect a much higher level of due diligence/research with a project that has such a high impact on your residence and that will set a precedent for what is acceptable moving forward. The town decided to circumvent bylaws in order to erect a 150 cell tower in a residential neighborhood. The town attempted to change the bylaw at the town meeting last October to fit the project. This project started abruptly after the proposed cell tower IN New Seabury was dropped. Blue Sky and the current town planner have talked about alternative sites on many occasions. I would like to see them but it seems as if they don't exist.

Was there a RF engineer consulted prior to writing the RFP to determine if the site was viable? Did you reach out to the federal government to determine if one of there parcels could be used? Did you reach out to the Mashpee Water District to determine if there parcel in New Seabury could be used? Did you reach out to the Peninsula Counsel to see if there was a parcel you could work with? Have town owned parcels inside the wildlife reserve been considered? Have you reached out to the state to determine if any of there parcels are suitable (36 Wells Rd)? This is all due diligence that I would expect prior to the RFP being written.

This project has been far from transparent. I just want proof that this is the best and only site that can be used. It would be a much easier pill to swallow if that were the case. It seems too far outside of the effected area for that to be so. This is just elongating this project and doing even more disservice to the residence in New Seabury. The longer this goes on, the longer they are left vulnerable.
