

Town of Mashpee Sticker Application

2023/2024 Season

Only Mashpee residential property owners and year-round renters are eligible to purchase stickers. Visitors may purchase one-week beach passes and one-trip transfer station passes.

Pay online by credit card, or order by mail.
Stickers and/or passes will be mailed beginning June 1, 2023.

STICKERS, PASSES AND PERMITS

FY24 TRANSFER STATION STICKER (valid July 1, 2023 – June 30, 2024)

A Sticker or Pass is required to use the Mashpee Transfer Station for household trash and recyclables. Only two (2) stickers per household are allowed. Visitors may only purchase one-trip passes.

FY24 RECYCLING STICKER (valid July 1, 2023 – June 30, 2024)

For recycling only (no household trash), a recycling sticker is required. If you are purchasing a Transfer Station sticker, you do not need a Recycling sticker on the same vehicle.

2023 RECREATION (BEACH) STICKER (valid June 2023 – September 5, 2023)

During the summer season, a sticker is required to use the three public beaches in Mashpee (South Cape Beach, Attaquin Park, and John's Pond). Visitors to Mashpee may only purchase weekly passes to use the beaches. Tribal members may access the beach by displaying their tribal sticker on the vehicle or showing their Tribal ID. **(No trailers allowed at John's Pond.)**

2023 BOAT RAMP STICKERS - Transfer Station Stickers, Recycling Stickers, Recreation Stickers and Boat Ramp Stickers are accepted as proof of residency for Boat Ramp parking. Boat Ramp parking is on a first come, first served basis.

2023/2024 SHELLFISH LICENSE (valid April 1, 2023 – March 31, 2024)

A permit is required for the taking of shellfish from the waters of Mashpee. Users of a family permit may include the permit holder, their spouse, and their children under the age of 18 years. A senior permit is available for residents 62 and older.

Non-residents who do not own property in Mashpee may purchase a permit at the non-resident rate, provided they reside elsewhere in Massachusetts. Tribal members may shellfish with their Tribal ID.

2023 SECONSETT ISLAND ONLY (valid June 2023 – September 5 2023)

Nonresidents who own moorings off Seconsett Island, or Falmouth residents entitled to shellfish there, may purchase parking passes for \$100.00. The pass is VALID ONLY FOR SECONSETT ISLAND.

STICKERS, PASSES AND PERMITS

For 2023-2024, stickers, passes and permits may be purchased online or by mail.

TO ORDER BY MAIL, SEND THE FOLLOWING:

1. COMPLETED APPLICATION.

Incomplete applications will be held at the Town Clerk's Office. Please list your phone number and email address so that if there is an issue with your application, we can let you know.

2. FOR TRANSFER STATION, RECYCLING, RECREATION (BEACH), AND BOAT RAMP STICKERS:

You must send a copy of the current registration for each vehicle for which a sticker is required. If the vehicle is leased and the registration does not show your name, send a copy of a document showing both your name and the vehicle's VIN. If the vehicle is registered to a business, send documentation linking your name to the business.

All vehicles must be registered to either the Mashpee address or the address shown on your tax bill.

Only two (2) Transfer Station Stickers may be purchased per household.

3. FOR SHELLFISH LICENSES ONLY:

Send a copy of the driver's license for each person for whom a permit is requested.

4. IF YOUR HOME IS NEWLY PURCHASED:

A copy the Closing Disclosure or Deed

5. FOR MASHPEE VISITORS:

Send a copy of your lease or rental agreement for the Mashpee location along with your vehicle registration.

6. A CHECK OR MONEY ORDER payable to "Town of Mashpee" for the total amount due.
